## Peru Select Board Meeting Minutes January 20, 2016

Clean-up Community House Basement: Gail reported that Fran Tobia from the Peru Fair Committee has requested that 4 tents, all trash cans and 2 small pop ups be left in basement. The remaining items can go but if there is a question regarding possible value, the Select Board will be contacted.

Hazard Mitigation Plan: The Select Board discussed whether it made sense to go forward with the plan. Charlie made a motion to table item at this time; Gail seconded; all in favor; motion passed.

**Meeting with PACIF:** No report submitted to answer. Charlie will follow up.

## Other Business
