Auditor's Request for Policy Regarding Use of Town Credit Card: Todd made a motion that any use of the Town credit card, with the exception of already preapproved recurring expenses, must be approved by the Selectboard; Chuck seconded; all in favor; motion passed.

**Approval of Liquor License:** Todd made a motion to approve a request to cater malt, vinous and/or spirituous liquors by Denpos LLC, doing business as Johnny Seesaw's, on 12/17/2018 in their event barn; Chuck seconded; all in favor; motion passed.

**Dehumidifier:** In an attempt to resolve the moisture issue in the Town Hall basement Todd made a motion to allow Jill to use the Town credit card to purchase the recommended dehumidifier from Amazon.

Correction of Account Coding: Todd made a motion to correct the coding of a preapproved tree maintenance expense from account 464 to 452; Gail seconded; all in favor; motion passed.

**Road Foreman Report:** Wayne reported that the trucks are holding up well. One third of the salt budget has been used already due to the early storms. The road crew continues to work on push backs, guardrails, and turnarounds in preparation for the next storm.
