#### **NEW BUSINESS**

Martina Barnes - US Forest Service Manchester District Ranger – Martina provided an overview of areas of interest for Peru. The town of Peru has 17,104 acres of forest service land. Hapgood Pond - planning to have return volunteer host this summer. Possibility of a golf cart being used for water testing. To be followed up on when more details are known. They are hoping to install an automated fee machine this summer so that folks can pay with credit card. Youth Fishing Derby is cancelled this year due to Covid 19. Area trails got high use this past year. Forest service is working to manage all of the trails. Due to increased use, the Green Mtn. Club will be hosting 4 weeks of Long Trail trail crew to maintain some local trail segments.

Jon inquired about the logging job on Old Job. Hunter Excavating won the contract. These contracts are 5 year contracts. Hunter could start next winter, or it could be another year or two out still. That lumber will be hauled through Peru.
